- 02. Accordingly, retired Nursing Officers with following qualifications may apply for it:
  - I. Being a Government Nursing Officer below 65 years of age by 30.06.2019, capable of serving at least for a period of one year;
  - Being an officer who has retired by reaching the age of compulsory II. retirement without being subject to any disciplinary action;
  - III. Being an officer certified by a medical recommendation physically and mentally fit for further service.

### 03. Important:

- A monthly remuneration under Public Administration Circular 03/2018 I. will be paid to officers recruited on Contract Basis;
- II. The officers of the above services who have retired after serving in Special Grade of posts, if applied for this post, will be re-employed in Grade III posts.

### 04. Procedure of application

- I. Officers of the Nursing Service who are on compulsory retirement from Public Service by now should submit their applications prepared in the form EST-01 appearing in the website of the Public Service Commission, by hand or by registered post to the Commissioner General of Ayurveda through and with the recommendations of the Head of the institution he/she last served in.
  - (Only EST-01 form should be used for submission of applications).
- 05. Following documents should be submitted with the application:
  - I. Request of the officer;
  - II. Bio-data sheet of the officer;
  - III. Application submitted under Public Administration Circular 03/2018;
  - IV. A certified copy of the letter of retirement of the officer from public service;
  - V. A certified copy of the National Identity Card;
  - A certified copy of the Birth Certificate; VI.
  - Medical Report (obtained within a period of 04 weeks by the date of VII. submission of the application).
