Accordingly, officers who will be recruited to the above posts from Government All Island Services will be paid an allowance of 50% of the basic salary of their respective post of the project in addition to the present salary and entitlements. Further, persons who will be recruited to the above posts from outside the Government Services will be paid as indicated under each post above.

Terms and Conditions:

Officers belong to All Island Services will be recruited as per DMS 01/2019 and persons outside the Government Services will be recruited on contract basis. All appointments will be made initially for a period of one year and may be renewable annually subject to the satisfactory performance appraisal. All conditions in the Management Services Circular No.01/2019 of 05.03.2019 will apply in relation to the appointments.
