Reduction of Landslide Vulnerability by Mitigation Measures Project

VACANCIES

Applications are invited from Sri Lankan citizens for the position of Project Director under the Reduction of Landslide Vulnerability by Mitigation Measures Project (RLVMMP) funded by the Asian Infrastructure Investment Bank (AIIB) and the Government of Sri Lanka (GoSL), with a project value of US\$ 101.3 million. The Ministry of Defence acts as the executing agency, with the National Building Research Organisation (NBRO), under the Ministry of Defence, serving as the implementing agency. The project aims to mitigate landslide risks at 128 identified locations across the districts of Badulla, Kandy, Matale, Kegalle, Ratnapura, Nuwara Eliya, Kalutara, Colombo, Matara, and Kurunegala, as well as unstable areas along railway tracks. Phase I successfully mitigated critical landslide-prone sites, and Phase II is now addressing the remaining sites.

Educational Qualifications & Work Experience

The position of the Project Director will be a full-time position on a contractual basis and the tenure will be co-terminus with the project end date (including three months Probationary Period).

The applicant must be under the age of 64 as of the application date.

Experience in foreign-funded projects is preferred.

At least 12 years post qualifying experience at Managerial level out of which 06 years should be in the senior Managerial Level.
- 3) A successfully completed Bachelor's Degree in the relevant field, which is recognized by the University Grants Commission, or
A qualification Recognized by the University Grants Commission as an equivalent Qualification to the Degree in the relevant field,
And
A post Graduate Degree in the relevant Field with,
Corporate/ Chartered membership or a similar professional qualification obtained from a recognized professional Institution in the relevant field with,
At least 10 years post qualifying experience at Managerial level out of which 05 years should be in the senior Managerial Level.

Educational Qualification in Project Management (Project Planning, Implementation, Monitoring and Evaluation) and Experience in foreign-funded project are preferred.

The remuneration and other terms and conditions applicable to the position are outlined in Management Services Department (MSD) Circular No. 01/2019, issued by the Ministry of Finance on 05.03.2019.
