**VACANCIES**

The Reduction of Landslide Vulnerability by Mitigation Measures Project (RLVMMP), implemented under the Ministry of Defence funded by Asian Infrastructure Investment Bank (AIIB) aims to reduce landslide risk and severity, minimizing loss of life and economic damage. The National Building Research Organisation (NBRO) is the executing agency. The project consists of four components and 127 landslide-prone locations & the total cost is USD 101.3 million. Land slide mitigation works (127 locations) in Badulla, Kandy, Matale, Kegalla, Ramapura, Nuwara Eliya, Kalutara, Galle, Matara, Hambantota & Kurunegala districts and unstable locations along the railway track will be improved under this project.

Applications are hereby invited from Sri Lankan citizens for the following positions for Project Implementation Unit (PIU) will establish in Nawalapitiya for Construction supervision of 03 Contracts worth approximately LKR 3.60 billion were awarded under Package 8, covering 22 project sites on a 225 km stretch of the upcountry railway line.

**1. Health &**

**Safety Specialist**

**(01 Position - PS 4 level)**

**Minimum Qualifications and Experience:**

a) A successfully completed bachelor's degree in a relevant field that is recognized by the University Grants Commission

An associate membership/a similar professional qualification obtained from a recognized professional institution in the relevant field

**or**

Having obtained a certificate of proficiency not below than the National Vocational Qualification Level 7, issued by a Technical / Vocational Training Institute accepted by Tertiary and Vocational Education Commission for a post related to the relevant field

**and**

At least 03 years of post-qualifying experience in environmental health and safety field

**Or**

b) Having obtained a certificate of proficiency not below than the National vocational Qualification Level 6 issued by a Technical / Vocational Training Institute accepted by Tertiary and Vocational Education Commission for a post related to the relevant field

**and**

At least 08 years of experience in environmental health and safety field

**Or**

c) Having obtained a certificate of proficiency not below than the National Vocational Qualification Level 5 issued by a Technical / Vocational Training Institute accepted by Tertiary and Vocational Education Commission for a post related to the relevant field.

**and**

At least 13 years of experience in environmental health and safety field

**3. Technical Officer - Civil**

**(04 Positions-PS 6 level**

**Category A)**

**Minimum Qualifications and Experience:**

a) A successfully completed bachelor's degree in a relevant field which is recognized by the University Grants Commission

**or**

A qualification recognized by the University Grants Commission as an equivalent qualification to the degree in the relevant field

**or**

An associate membership/a similar professional qualification obtained from a recognized professional institution in the relevant field

**or**

Having obtained a certificate of proficiency not below than the National / Vocational Qualification Level 7, issued by a Technical Vocational Training Institute accepted by Tertiary and Vocational Education Commission for a post related to the relevant field

**and**

At least 03 years of post-qualifying experience in Civil Construction field

**Or**

b) Having obtained a certificate of proficiency not below than the National Vocational Qualification Level 6 issued by a Technical / Vocational Training Institute accepted by Tertiary and Vocational Education Commission for a post related to the relevant field

**and**

At least 08 years of experience in Civil Construction field

**Or**

c) Having obtained a certificate of proficiency not below than the National Vocational Qualification Level 5 issued by a Technical / Vocational Training Institute accepted by Tertiary and Vocational Education Commission for a post related to the relevant field.

**and**

At least 13 years of experience in Civil Construction field

The applicant must be under the age of 64 as of the application date.

The recruitments will be initially for six (06) months on a contract basis and renewable thereafter. Applications from candidates in State Service, Statutory Boards, Corporations, or other Government Institutions should be forwarded through the Heads of relevant institutions, who should state whether the applicant can be released or not, if selected.
