**QUALIFICATIONS FOR VACANCIES**

**01. Technical Officer (Chemical) Grade III**

**Qualifications :**

- (i). should pass in three (3) subjects at the G.C.E. (A/L) examination in one sitting in Science Stream;

**AND**

- (ii). (a). Diploma in Medical Laboratory Technology

**OR**

- (b). Having Obtained a certificate of proficiency not below than the N.V.Q. Level 5 issued by a Technical/ Vocational Training Institute accepted by the Tertiary and Vocational Education Commission or recognized Institution in the field of Chemistry/ Chemical Engineering

**Note** : Acceptability of the qualification mentioned in above (ii) (b) shall be judged by the Faculty concerned

**Age** : Not less than 18 years and not more than 45 years of age on the closing date of applications.

**Selection by** : By written and/ or practical test and an Interview

**Salary Scale** : UMT 1(III)

## **02. Technical Officer Gr. II Seg 'B'**

### **Qualification :**

- i. (a) Three (03) G.C.E. (Advanced Level) Passes in Science Subjects in one sitting: subject combination (s) to be decided by the faculty concerned upon the recommendation of the department.

**AND**

(b) Passed a skill oriented formal programme of training relevant to the post of at least one year (full – time) duration or equivalent. The acceptability of the training programme for this purpose shall be judged by the faculty concerned.

**Age** : Not more than 45 years of age on the closing date of applications.

**Selection By** : By Written Test and Practical Test and an Interview

**Salary Scale** : UMT 1(III)  
Rs. 31,625- 7x300-10x355- 37,275/= (p.m.)

### **03. Technical Officer (Audio Visual) Grade III**

**Qualification :**

- i. Should pass in three (03) subjects at the G.C.E. (A/L) examination in any stream.

**AND**

- ii. (a) Having obtained a certificate of proficiency not below than the N.V.Q. Level 5 in the field of Electronics and Telecommunication/ Electronics/ Multimedia or Audio Visual Techniques from an Institute recognized by Tertiary and vocational Education Commission or a Statutory Institution which has been established by an Act Passed by the Parliament.

**OR**

(b) Having obtained technical qualifications in the field of Electronics and Telecommunication/Electronics/Multimedia or Audio Visual Techniques accepted as equivalent to the above qualification of (ii) (a) by Tertiary and vocational Education Commission with one year experience in Audio Visual Work in a reputed organization.

Age : Not less than 18 years and not more than 45 years of age on the closing date of applications.

**Selection By** : By Written and/ or Practical Test and an Interview

**Salary Scale** : UMT 1(III)

#### **04. Laboratory Attendant Gr. III**

**Qualification :** i. Should have passed the G.C.E O/L Examination in six subjects (06) with at least two credits passes in not more than two sittings.

AND

ii. Having obtained a certificate of proficiency of the NVQ Level 2 or 3 in a field which has knowledge of standard laboratory equipment and laboratory techniques issued by a Technical/Vocational Training Institute accepted by the Tertiary and Vocational Education Commission or a statutory institution which has been established by an Act passed by the Parliament.

**Note :** Minimum six months working experience in a similar capacity with knowledge and use of standard laboratory equipment, supplies, and ability to learn new laboratory techniques as needed may consider equal NVQ level 2 or 3 until such programs are designed as appropriate for the post of Laboratory Attendant.

**Age :** Not less than 18 years and not more than 45 years of age on the closing date of applications.

**Selection By :** By aptitude test and Interview

**Salary Scale :** UPL 2(III)  
Rs. 28,025- 16x270- 32,345/= (p.m.)

In addition to the above basic salary, other allowances approved by the University Grants Commission will also be paid as per the relevant regulations. i.e;

#### **CONDITIONS OF SERVICE:**

01. These posts are permanent. The appointments will be on probation for a period of three (03) years.
02. Selected candidates if presently serving in a Government Department will have to obtain his/ her release through their respective appointing authority.
03. Government employees will not be entitled to maintain their pension rights whilst in the University Service.

## **BENIFITS**

01. Selected candidates will begin to contribute to the Universities Provident Fund by means of monthly deductions from his/ her salary and amount equal to ten (10%) percent of his/ her basic salary. The University will, in addition out of its funds contribute at the same time a sum equal to seven (07%) percent of his/ her earnings to the Universities Provident Fund and eight (08%) percent of his/ her earnings to the Pension Fund.
02. Three (03%) per centum of his/ her basic salary will be contributed by the University to the Employees Trust Fund in terms of Provision of the Employees Trust Fund.
